**GENERAL TERMS & CONDITIONS FOR EMPANELLED SELF EMPLOYED  
REHABILITATION PROFESSIONALS (PROSTHETIST & ORTHOTIST)**

1. You will be paid consolidated monthly professional service charges of Rs 14000/- for Delhi, Mumbai, Kolkata and Bangalore or 12000/- for any other city within the country.
2. For providing your services primarily you will attend camps in any place in India as assigned to you, visit our clients for procurement of orders and collection of sales proceeds, carry out fabrication & fitment of Prothesis & Orthosis and misc. jobs as assigned to you mostly outside ALIMCO premises. Your traveling expenses and outstation boarding & lodging expenses shall be paid as under:-
  - a) Travel : To & fro journey fare by Second Sleeper class by Rail/Express Bus on production of proof.
  - b) Accommodation : Rs. 500/- per day for principal cities (Delhi, Kolkata, Mumbai, Bengalore) and Charges against Receipt Rs 400/- per day for other cities,
  - c) D.A. expenses : Rs. 200/- per day for stay on own arrangement and not in Hotel in principal cities and Rs. 160/- per day for the period of stay on own arrangement And not in hotel in other cities. In case of stay in Hotel D.A. @ 50% shall be paid as Applicable.
  - d) Local Conveyance : At actuals subject to maximum of Rs. 60/- per day. at the deputed place of work
3. For fulfillment of assignment, no advance payment shall be given by the Corporation. However, same will be reimbursed as per above Terms & Condition on submission of claim.
4. Your period of hiring professional services as Rehabilitation Professional (P&O) shall be purely as need basis for providing services to ALIMCO in its Auxiliary Production Centers at Jabalpur, Bhubaneswar & Bangalore or Regional Marketing Centers at Delhi, Kolkata & Mumbai, ALIMCO Outreach Centre, Guwahati and Corporate Head Quarters at Kanpur as agreed upon by ALIMCO or any where in India..
5. Your initial location (city) shall be communicated to you and you may be shifted to any other place as per requirement of the Corporation to provide professional services.
6. During the agreed period you shall be present at the assigned place between 0900 Hrs. to 1730 Hrs. However, days/hours of work may change as per the demand of the services.
7. In case of exigencies at site due to customer/patients demand and expectations, you may be required to stay back beyond normal working hours occasionally for which no additional payment shall be made
8. You shall liase for your assignments and professional services with the authorized executives of the Corporation.

9. During the period of empanelment, you are expected to project good image of the Corporation and also to observe and maintain decorum and discipline within as well as outside the Corporation premises and shall ensure your security & safety and also safety of the premises and the property of the Corporation.
10. The Corporation shall have the right to terminate your empanelment with one week's notice and you shall not have any claim for payment of any compensation or otherwise for balance period of empanelment. You can also similarly terminate this empanelment by giving one week's notice in writing to ALIMCO.
11. Any statutory charges such as taxes/levies, if applicable for professional service charges, shall have to be borne by you.
12. You are not permitted to divulge any trade secrets or official documents of the Corporation to anybody neither or to indulge in any activity which shall not be in the interest of ALIMCO. If you are found to be involved in any such activities, ALIMCO shall terminate the empanelment immediately and may take any other action as deemed fit.
13. If any dispute/question or controversy arises, the settlement of which is not herein specifically provided, the matter of dispute shall be referred to the arbitration of Chairman & Managing Director of ALIMCO or his nominee and the decision of Chairman & Managing Director or his nominee shall be final and binding on both the parties. The provision of INDIAN ARBITRATION & CONCILIATION ACT 1996 as amended from time to time shall apply to such arbitration proceedings. Arbitration proceeding shall be held at Kanpur only and the Kanpur Courts will have jurisdiction in the matter.
